Certificate/Class Credit Information

100% attendance is required for OSFM certification courses. Attendance will be taken twice on each day of class. Certificates will be mailed to all participants.

Minimum Age Requirements

The minimum age for participation in the Lenoir Community College Public Safety School is mandated by OSFM, NCCCS, and/or LCC policies for each class. All participants under the ages of 18 and currently attending high school must have concurrent enrollment forms signed by the high school principal.

Concurrent Enrollment forms must be returned with the registration.

Enrollment for participants under the age of 18 will be limited only to classes that **do not** state; *Students must meet minimum age requirement (18 years of age or older).*

OSFM Certification Courses

FIP 3045 FF Fireground Ops 5 (32 hours)

Section #2501

Tuesday, Wednesday, Thursday, Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course includes instructional content for Ladders and Ventilation. This course will present the candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1001: Standard for Firefighter Professional Qualifications (2019 edition).

Full turnout gear with SCBA required.

FIP 3047 FF Fireground Ops 7 (20 hours)

Section #2502

Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course includes instructional content for Water Supplies. This course will present the candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1001: Standard for Firefighter Professional Qualifications (2019 edition).

Full turnout gear without SCBA required.

FIP 3048 FF Fireground Ops 8 (20 hours)

Section #2503

Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course includes instructional content for Hose, Streams, and Appliances. This course will present the candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1001: Standard for Firefighter Professional Qualifications (2019 edition).

Full turnout gear without SCBA required.

FIP 7001 FF/TR Emergency Medical Care (12 hours)

Section #2504

Saturday 8 a.m. – 5 p.m. and Sunday 8 a.m. – 12 p.m.

This certification-related course is designed to give the candidate a basic understanding of emergency medical care procedures as well as all of the information required to meet the knowledge, skills, and abilities to satisfy the key requirements of NFPA 1001: Standard for Fire Fighter Professional Qualifications (2017 edition; Chapter 6)

FIP 3600 D/O: Emergency Vehicle Driver (24 hours)

Section #2505

Thursday and Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course deals with the safe operation of emergency vehicles, driving skills, legal implications of emergency driving, departmental standard operating procedures, and abilities to satisfy the key requirements of NFPA 1002: Standard for Fire Apparatus Driver/Operator Professional Qualifications (2017 edition).

Students must be 18 years of age and possess a valid NC Driver License.

Clothing appropriate for weather conditions recommended.

FRC 1202 TR Rope Rescue Awareness (8 hours)

Section #2506

Tuesday and Wednesday 6 p.m. – 10 p.m.

This certification-related course in rope rescue (awareness level) will present the Technical Rescuer (TR) with an introduction to rope rescue, size-up, hazards associated with rope rescue, supporting the operations, initiating a response, and technician level rescue incident.

FRC 1208 TR Passenger Vehicle Awareness (8 hours)

Section #2507

Thursday and Friday 6 p.m. – 10 p.m.

This certification-related course in common passenger vehicles (awareness level) will present the Technical Rescuer (TR) with an introduction to vehicle rescue and extrication, vehicle rescue incident awareness, and rescue tools and equipment.

Full turnout gear without SCBA required

FRC 1209 TR Passenger Vehicle Operations (16 hours)

Section #2508

Saturday and Sunday 8 a.m. – 5 p.m.

This certification-related course in common passenger vehicles (operations and technician level) will present the Technical Rescuer (TR) with information on vehicle anatomy and will introduce new technologies in vehicle devices which present hazards for rescue personnel. Topics included in this course are site operations, mechanical energy and vehicle anatomy, supplemental restraint systems, and advanced vehicle technology: alternative fuel vehicles.

Full turnout gear without SCBA required.

FIP 3811 Fire Instructor I (28 hours)

Section # 2509

Wednesday, Thursday, and Friday 6 p.m. – 10 p.m., Saturday and Sunday 8 a.m. – 5 p.m.

This course will present the Instructor I candidate with the knowledge, skills, and ability to satisfy the requirements of NFPA 1041: Standard for Fire and Emergency Services Instructor Professional Qualifications (2019 edition; Chapter 4).

FIP 3716 Fire Chief 101

Section # 2510

Saturday 8 a.m. – 5 p.m.

This certification-related course is designed to apprise chief officers of the various aspects and complexities surrounding the operations and organization of North Carolina Fire departments. Emphasis will be placed on ratings and inspections, NFIRS reporting, prevention and relief funds, grant programs, basic line of duty death information, various state associations, and an overview of chief officer expectations in North Carolina. This class will satisfy the 9S insurance inspection criteria as specified by the North Carolina Administrative Code.

NFA Course

FIP 3517 NFA Leadership Growth (16 hours)

Section #2511

Saturday and Sunday 8 a.m. – 5 p.m.

This is National Fire Academy (NFA) "Leadership in Supervision: Creating Environments for Professional Growth" Course 0646. This course presents the supervisor with the basic leadership skills and tools needed to perform effectively in the fire and emergency medical services (EMS) environment. The course includes concepts related to a successful transition to supervisory and leadership roles, including concepts of adaptive leadership; change management; active followership; effective communication, including difficult conversations and advocacy-inquiry based dialogue; ethics; authority; power; decision-making; and active engagement through development of a personal plan. Specific guidelines must be followed for all NFA courses.
